Chase County Commissioners December 12, 2023

The regular meeting of the Chase County Commissioners was called to order at 8:00am on Tuesday, December 12, 2023 by Chairman Jacci Brown in the meeting room of the Chase County Courthouse. Also in attendance were Commissioner Billie Muehlenkamp and county clerk Wendy Moe. Commissioner Bernhardt was absent. The meeting was advertised in the Imperial Republican. The agenda and open meetings act were posted. With nobody present for open forum commissioners moved on to agenda items.

Leanne Klein and Jason Arellano were present on behalf of Wauneta EMS and Deb Hayes was present on behalf of Imperial EMS. EMS squads have concerns with the new radio system. Since the transition to the new digital system, they are now unable to communicate with their analog pagers and radios. The original page is received via the digital system but then they cannot communicate between EMS/Fire departments with their analog handheld devices. Both services indicated that they have been switching to analog in order to communicate with one another for EMS but then are unable to hear what may come across the digital feed as Fire is all running on the new digital system. This is a concern as they feel that continuity of care suffers for their patients as radio traffic with the analog system previously helped them to have a heads up of emergency situations and make them more aware of what is going on and what may be needed as far as mutual aid, coming and going of ambulances, etc. The EMS services think everyone switching back to analog for the time being would be a practical short-term solution until everyone is fully digitally capable. That would entail all handheld analog devices being replaced with digital devices. Estimated cost is about \$1000 per device.

Commissioner Brown asked if they have any other concerns with the digital system as she had been informed that the new digital devices are difficult to hear due to static and being unclear. Both services agreed that communications are sometimes hard to hear with the digital system.

EMS personnel also expressed concern over the new numbering system. Previously ambulances were identified using the name of the town followed by the number 99, this numbering is widely used across the state, radio identity including the number 99 indicates it is an ambulance. With this new system, they are identified as 72XX with a numbered being assigned to each unit. They feel this is problematic and don't understand why it was changed from the original numbering system.

Commissioners agree that the best short-term solution for the communication concerns is to switch everyone back to analog for now until everyone has fully digital capable handheld devices.

Commissioner Brown will get in touch with Emergency Manager Duane Dreiling and Rick Elliott at PSC to see what needs to be done to get things changed back to analog for the time being.

Assessor Tori Mueller joined the meeting for agenda item concerning the signing of Contract for Professional Appraisal Services with Pritchard & Abbott for 2024-2025. Pritchard & Abbott provides appraisal services for all Mineral Property within the county. This entails mostly gas and oil properties. Commissioner Brown moved to sign the contract for professional appraisal services with Pritchard & Abbott for tax years 2024 and 2025. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp — yes; Brown — yes; Bernhardt — absent. Motion carried.

Commissioner Brown moved to approve the minutes from the November 28, 2023 meeting. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – absent. Motion carried.

Commissioner Muehlenkamp moved to designate the Imperial Republican as the official county newspaper for 2024. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – absent. Motion carried.

County Highway Superintendent discussed. On August 8, 2023, Richard DeWester was hired for the position of County Highway Superintendent. This is to clarify that Richard DeWester, License S-1761, Class B, will assist the current, Licensed and Appointed County Superintendent, Anthoney Krajewski, License S-1021, Class A, so the county can continue to receive a Highway Incentive payment based on a Class A Superintendent License, as Mr. Krajewski holds. Commissioner Brown moved that it be made a matter of record that Richard DeWester was hired as an assistant to current Highway Superintendent Anthoney Krajewski. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – absent. Motion carried.

At 9:00 Caleb Johnson of J13 Enterprises, LLC joined the meeting to present the board with a budget preparation proposal. Mr. Johnson explained his budget preparation process and presented the board with two proposals, the first for a one-year agreement and the second for a three-year agreement. Commissioners are interested and indicated that they would prefer the three-year agreement but first want to confer with the county's current budget preparer before making any decisions. This item will be put on the agenda for the next meeting.

Commissioner Brown moved to surplus a wooden table (tag #464) from the Treasurer's office to be transferred to the office of the County Clerk. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – absent. Motion carried.

Commissioner Muehlenkamp moved to transfer a desk (tag #196) from the county attorney's office to the clerk's office. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – absent. Motion carried.

Commissioner Muehlenkamp moved to transfer a desk corner piece from the county attorney's office to the transit office. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – absent. Motion carried.

Commissioner Brown moved to approve claims as submitted. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – absent. Motion carried.
