Chase County Commissioners January 23, 2024

The regular meeting of the Chase County Commissioners was called to order by Chairman Jacci Brown at 8,00am on Tuesday, January 23, 2024 in the meeting room of the Chase County Courthouse. Also in attendance were Commissioners Billie Muehlenkamp and Kurt Bernhardt, County Clerk Wendy Moe, Sheriff Kevin Mueller, Road Secretary Jeni Lotspeich and Weed Superintendent Brandon Beard. The open meetings act and agenda were posted. The meeting had been advertised in the Imperial Republican. With nobody present for Open Forum Commissioners proceeded with Agenda items.

Weed Superintendent Brandon Beard presented the Annual County Weed report to the board. Commissioners had questions pertaining to the status of Bindweed. Brandon said it is no longer classified as a noxious weed in the State of Nebraska but the board could choose to classify it as such on the county level. Commissioners indicated that they may want to further explore this option. With no further questions for Brandon, Commissioner Bernhardt moved to approve the signing of the Annual Weed Report. Motion seconded by Commissioner Muehlenkamp.

Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Sheriff Mueller joined the meeting to discuss the law enforcement contract currently in place between the County and the Village of Wauneta. The contract has been in place since 2018 with no rate increase. The current contract allows for 80 hours of coverage monthly at a rate of \$22,000 per year which equates to \$22.91 per hour. Sheriff Mueller recommended that the cost be increased to \$36,480 annually with a three to five percent cost of living increase each year. Given the proposed figures the hourly rate would increase to approximately \$38.00 per hour. Sheriff Mueller recommended that this rate increase go into effect when the Village goes into their new budget year. Commissioners agreed with these recommendations and directed Sheriff Mueller to draft a letter and send it to the Wauneta Village Board.

Board reviewed the specifications submitted by Emergency Manage Duane Dreiling for a new generator to be placed at the courthouse. Specs included that it be able to handle the courthouse load up to 40kw, have a minimum of five switches, a service contract must be included as well as a concrete pad for placement and bidder would be responsible for running all proper hookups into the courthouse. Black Hills will run the gas line to the new location. Commissioner Brown moved to approve the bid specifications and directed that they be advertised to be opened on February 27th and 9:00am. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Brown moved to appoint Marci Fanning to fill the vacant seat on the Planning & Zoning Board.

Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to approve the minutes from the January 9, 2024 meeting as written. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.
