Commissioner Bernhardt moved to approve the minutes from the October 24, 2023 meeting. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Treasurer Rebecca Bernard and County Attorney Joel Burke joined the meeting for agenda items of FY25-26 SW NE Juvenile Services MOU and MOU Authorizing Rory Roundtree to sign for SW NE Juvenile Services. County Attorney Burke is of the opinion that it may be in the best interest of the County to step down from the program as Lead County seeing how the primary contacts for the program are no longer employees of Chase County but are instead employed by other participating counties in the program. Commissioner Bernhardt directed the County Attorney to send letters to program administrators Karen Baker and Rory Roundtree notifying them that Chase County no longer wants to be the Lead County for the Southwest Nebraska Juvenile Diversion program.

Commissioner Bernhardt moved to table the agenda item of FY25-26 SW NE Juvenile Services MOU until the November 28, 2023 meeting. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp — yes; Brown — absent; Bernhardt — yes. Motion carried; item tabled until next meeting.

Commissioner Bernhardt moved to table the agenda item of MOU Authorizing Rory Roundtree to sign for SW NE Juvenile Services until the November 28, 2023 meeting. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried; item tabled until next meeting.

Commissioner Bernhardt moved to approve Resolution #2023-21 for Amendment and Addendum to NIRMA/NIRMA II Intergovernmental/Interlocal Agreements to renew the county's commitment to participate in NIRMA from July 1, 2024 through June 30, 2027. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp — yes; Brown — absent; Bernhardt — yes. Motion carried. A complete copy of the resolution is on file in the office of the county clerk.

Commissioner Bernhardt moved to approve Resolution #2023-20 for the Signing of the Year-End Certification of County Highway Superintendent 2023. Motion seconded by Commissioner Muehlenkamp — yes; Brown — absent; Bernhardt — yes. Motion carried. A complete copy of the resolution is on file in the office of the county clerk.

Commissioner Bernhardt made a motion to have the Chairman sign the Year-End Certification of County Highway Superintendent for Determining Incentive Payment in Calendar Year 2023. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried. Separate forms will be completed and submitted for both Anthoney Krajewski and Richard DeWester.

Commissioner Muehlenkamp gathered informal bids from Harchelroad Ag, Titan Machinery and Yost Farm Supply for a new mower for the Wauneta Shop. Commissioner Muehlenkamp moved to accept the bid from Harchelroad Ag for an ironcraft mower in the amount of \$22,500. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

At 9:00 Gregg O'Brien from Nebraska Machinery and John Webster from Murphy Tractor joined the meeting for opening of Grader bids. Two bids were received. The first from NMC for a CAT 140-13 AWD 270hp with a 7 year/7500-hour premier warranty for a list price of \$383,200 and \$52,500 trade in value for the Deere 770G for a final price of \$330,700. The second from Murphy Tractor & Equipment for a John Deere 772G 275hp with an 84 month/7500-hour full machine, no travel, no deductible, no trucking warranty for a list price of \$431,429 with a \$64,000 trade in value for the Deere 770G with final price being \$367,429.

Commissioners Bernhardt moved to accept the bid from Murphy Tractor & Equipment for the John Deere 772G for \$431,429 with a trade in value of \$64,000 for the Deere 770G and a final purchase price of \$367,429. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp — yes; Brown — absent; Bernhardt — yes. Motion carried.

Commissioner Bernhardt moved to surplus a nonworking dell monitor, extra conference room chair with no base, nonworking canon desk calculator and multiple old keyboards from the road office to the trash. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to surplus a nonworking Black & Decker shredder and a nonworking dell computer monitor from the road office to the trash. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to surplus three nonworking Dell computer towers, county tag numbers 622, 629 and 670, from the road office to be recycled with Kellen Ripley. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to surplus a nonworking Brother fax/copy/scanner from the road office to the trash. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Commissioner Muehlenkamp moved to surplus a nonworking cordless phone, tag #562, and a nonworking typewriter, tag #675, from the Treasurer's office to the trash. Motion seconded by Commissioner Bernhardt. Muehlenkamp—yes; Brown—absent; Bernhardt—yes. Motion carried.

Commissioner Muehlenkamp moved to surplus a plastic desk chair mat from the Treasurer's office to the transit office at the new building. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to give Christmas gift certificates to county employees to be used at the local grocery store of their choosing; \$50 for part time employees and \$100 for full time employees. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Commissioner Muehlenkamp moved to appoint Austin Bernhardt to fill the vacant Fair Board position in District 1. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried. Position filled to replace the vacancy of Kenny Smith, for a three-year term to expire December 31, 2025.

With no further business to come before the board, Vice-Chairman Bernhardt adjourned the meeting at 10:15am.
