Chase County Commissioners June 11, 2024

The regular meeting of the Chase County Commissioners was called to order at 8:00am on Tuesday, June 11, 2024, by Chairman Jacci Brown in the meeting room of the Chase County Courthouse. Also in attendance were Commissioners Billie Muehlenkamp and Kurt Bernhardt, County Clerk Wendy Moe and Assistant Highway Superintendent Dick DeWester. The meeting had been advertised in the Imperial Republican. The agenda and open meetings act were posted.

Assistant Highway Superintendent DeWester was present to give the board quotes for security cameras at the road shops. Board directed that security cameras be added to the agenda for the next meeting.

Commissioner Bernhardt moved to approve claims as submitted. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Muehlenkamp moved to approve the minutes from the May 28, 2024, meeting as written. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Stephen Mulder from Liewer Funeral Home joined the meeting to request that the County consider purchasing a refrigeration unit to be kept at Liewer Funeral Home as they do not currently have any cold storage. This would be beneficial to the county in instances of unattended or suspicious deaths when an autopsy is necessary, currently the body must be immediately transported as there is no cold storage available locally. Stephen is proposing that the county purchase the cooler and it be housed at Liewer's and he would cover utilities and maintenance, the sheriff and deputies would have keypad access to the unit. The board asked if this would benefit other counties. Mulder indicated yes and suggested that the County charge other counties on a per use basis, as needed.

Commissioner Brown moved to direct the County Attorney to draw up an agreement between Chase County and Liewer Funeral Home pertaining to the purchase and use of a three-body mortuary cooler. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. Approval of agreement and purchase of cooler to be added to next agenda.

After a service call to the fairgrounds for an alarm panel error, Electronic Systems, Inc submitted a proposed work order for Bi-Annual Inspection of the fire alarm panel at the fairgrounds expobuilding as the system has not been inspected since 2016. Commissioner Bernhardt moved to accept the bid from ESI to inspect the Nutrien building fire alarm equipment twice annually for a price of \$300. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Assessor Mueller joined the meeting along with Sarah Dickmeyer with Schneider Geospatial who joined the meeting electronically to present the Beacon website to the Board as a replacement option for the county's current GWorks website. No action taken as the county still has one year on the current GWorks contract.

Board reviewed the NIRMA annual renewal rates, the County's annual contribution amount for 2024-25 is \$115,992. This represents a \$6,412 or 5.24% decrease from last year.

At 9:00 bids were opened for the Dump Road Project. Two bids were received. The first from Shelco Construction for \$542,641. The second from Simon Contractors for \$686,412. Highway Superintendent Toney Krajewski reviewed the bids and informed the Board that both were in order and met all specifications. Commissioner Brown moved to accept the bid from Shelco Construction in the amount of \$542,641. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

ESI also submitted a proposal for installation and monitoring of a cell communicator to monitor the fire alarm system and its equipment at the Nutrien building. Commissioner Bernhardt moved to approve the proposal for the monitoring contract with Electronic Systems Inc including a \$380 installation fee and \$35 monthly monitoring fee. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

The board began to review and prepare preliminary budget worksheets.

At 9:30 Chairman Brown recessed the meeting for Board of Equalization. The meeting was reconvened at 9:55.

The board continued working on preliminary budgets.

Discussion of Hospital Board, no action taken. The board directed clerk to add item to unfinished business.

Surplus property forms were submitted for the Board's review. Commissioner Bernhardt moved to surplus a Hon Office Chair (tag #671) from the Treasurer's office to the trash. Motion seconded by Commissioner Muehlenkamp - yes; Brown - yes; Bernhardt - yes. Motion carried.

Commissioner Brown moved to surplus two charcoal-colored chairs (tag #833 & 834) from the Clerk's office to be disposed of in the trash. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

A new service agreement for HVAC equipment in the courthouse was presented from Energy Wise Mechanical. It is a 2-year agreement in the amount of \$4,000 annually. Commissioner Brown moved to accept the new 2-year agreement from EWM, LLC. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Pankonin Ag Services submitted a request for a price increase for fertilization/weed control at the courthouse lawn. For the past four years pricing has been \$500 per application. Requested amount is \$650 per application beginning in the 2024 season to meet the input price increases. Commissioner Muehlenkamp moved to approve the requested price increase. Motion seconded by Commissioner Brown. Muehlenkamp - yes; Brown - yes; Bernhardt - yes. Motion carried.

With no further business to come before the Board, Chairman Brown adjourned the meeting at 11:10am.
