Chase County Commissioners May 14, 2024

The regular meeting of the Chase County Commissioners was called to order by Chairman Jacci Brown at 8:00am on Tuesday, May 14, 2024, in the meeting room at the Chase County Courthouse. Also in attendance were Commissioners Billie Muehlenkamp and Kurt Bernhardt, County Clerk Wendy Moe, Highway Superintendent Toney Krajewski and Assistant Highway Superintendent Dick DeWester. The meeting was advertised in the Imperial Republican and on the county website. The open meetings act and agenda were posted.

With nobody present for Open Forum, commissioners moved on to Agenda items. Highway Superintendent Krajewski was in attendance to present the plans and specifications for the Dump Road project. Toney indicated that the specs include an asphalt overlay, a leveling course, and a final course. There will be no tearing up of the existing road only a minimal amount of patching. There is no shouldering work included in the specs, that will be done by County Road employees after completion of the overlay project. Specifications require that the final completion of the project must be between September 1 and September 15, 2024.

Commissioner Brown moved to approve the plans and specifications for the Dump Road project as presented by Toney Krajewski. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Muehlenkamp moved to advertise for bids for the Dump Road Project to be opened on June 11 at 9:00am. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Jordan Gardner from Murphy Tractor joined the meeting for the agenda item of purchasing a Reclaimer for the Wauneta shop. Informal bids were sought but this is a specialty item that can only be purchased through Murphy so no other bid information was available. Commissioner Brown moved to purchase the reclaimer for the Wauneta shop from Murphy Tractor & Equipment for \$22,240. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Assistant Highway Superintendent Dick DeWester presented the final list of roads to be reclassified as Minimum Maintenance. Commissioner Bernhardt moved to have a Public Hearing on May 28 at 9:00am to hear testimony for or against the reclassification of seven segments of rural roads to minimum maintenance status. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. Segments subject to this hearing will be 745 Road and 321 Ave extending three miles west of 321; 746 Road and 321 Ave extending three miles west of 321; 320 Ave and 736 Road extending two miles south; 323 Ave and 736 Road extending north two miles; 740 Road and 326 Ave extending east one mile; 727 Road and 344 Avenue extending north one mile and 727 Road and 345 Ave extending one mile north.

Commissioner Bernhardt moved to approve claims as submitted. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt -yes. Motion carried.

At 8:30 bids for courthouse roof repair were opened for review. Three bids were received, one from Strong 1 LLC for \$79,650; one from Anchor Roofing & Landscaping for \$85,450 for the courthouse roof, \$11,125 for the restroom and lions building at the fairgrounds, and \$7,250 for the smaller roof section on the courthouse for a total of \$103,825; the third bid was from Weathercraft Co of McCook for \$91,770 for the courthouse roof, \$11,225.25 for the restroom and lions buildings at the fairgrounds and \$7,715.50 for the smaller roof section on the courthouse for a total of \$110,710.75. The bid from Strong 1 LLC did not meet specifications so it was not considered. Commissioner Muehlenkamp moved to accept the bid from Anchor Roofing for repair of the courthouse roof and restroom and lions building roofs at the fairgrounds in the amount of \$103,825.00 Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt- yes. Motion carried. NIRMA will contribute \$40,000 for the repair project, commissioners stated that the balance shall be paid from LATCF funds.

At 8:50 the bids for courthouse and extension cleaning services were opened. Two bids were received, one from Natalie Schra with a bid to clean both buildings for \$140 daily; second bid was from Terri Roach to clean both buildings for \$200 daily. Commissioner Bernhardt moved to accept the bid from Natalie Schra to clean the courthouse and extension buildings for \$140 per day. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Bernhardt moved to approve the minutes from the April 23, 2024 meeting. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Muehlenkamp moved to sign the letter of support for the Western Republican River Basin Riparian Habitat Improvement Project for funding. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. Chairman Brown signed the letter of support.

Resolution #17-22 regarding Cash-In-Lieu payment option for group medical insurance policy for elected officials and employees of the county was reviewed. The single monthly cash option amount of \$350 has not been adjusted since it went into effect in 2018. Commissioner Brown moved to increase the Cash-In-Lieu payment option to \$400/month to go into effect July 1, 2024. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

At 9:00am Chairman Brown recessed the meeting for Board of Equalization. Meeting reconvened at 9:10am.

The County's NACO Health and Dental insurance pool with Blue Cross Blue Shield Subgroup Application was presented for review and approval. The County received a 3.5% rate increase for health insurance in the 2024-2025 plan year. The dental rate remains the same. Commissioner Bernhardt moved to approve the BCBS application for the 2024-2025 plan year. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Commissioner Brown moved to sign the addendum to the interlocal road agreement with Perkins County. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

With no further business to come before the Board, Chairman Brown adjourned the meeting at 9:05am.
