Chase County Commissioners April 11, 2023

The regular meeting of the Chase County Commissioners was called to order by Chairman Jacci Brown on April 11, 2023 and 8:00am in the meeting room at the Chase County Courthouse. Commissioners Dinnel and Bernhardt as well as County Clerk Wendy Moe were also in attendance. The open meetings act and agenda were posted. Karen Baker joined the meeting for approval of a grant application requesting additional funding for Southwest Nebraska Juvenile Services. Baker explained that this is a competitive grant through the crime commission. She has written it requesting \$40.242.00 in additional funding for the Juvenile Services program. At 8:30 Bart and Ryan Stromberger, Stromberger Farms, along with Dean and Nicole from Settje Agri-Services & Engineering joined the meeting to present a proposal for a project that will consist of placing roller compacted concrete along the existing three miles of Road 734 west from the end of the current blacktop to the end of Stromberger feedlot. The estimated cost of the project is \$2,486,443.02. Stromberger Farms is willing to participate in improving the county road by paying for 25% of the project. Settje mentioned that there are possible grant funds of up to \$500,000 available to help with the project. At this point Strombergers are requesting approval and cost share from the county to move forward with project site exploration through boring to investigate subsurface soils for the project. Commissioner Dinnel would like to consult with county highway superintendent Toney Krajewski before making any decisions. Duane Dinnel moved to table this topic until commissioners have time to talk to Highway Superintendent Toney Krajewski. Motion seconded by Kurt Bernhardt. Jacci – yes; Kurt – yes; Duane – yes. Road 734 RCC project tabled.

Commissioner meeting recessed by Chairman Brown at 9:30 for Board of Equalization.

Commissioner meeting resumed at 9:47, present were Brian Hill with Lake Mac Assessment, Assessor Tori Mueller, and Deputy Assessor Terrie State to discuss appraisal services. In an effort to make assessed values across the county more consistent, Assessor Mueller would like to contract with Lake Mac Assessment to reassess all parcels in the county. Brian and a member of assessor's office staff will visit and assess all parcels, this will serve as a training process for the Assessor's office and make values across the county more consistent. Tori indicated that up until about 25 years ago the county had all assessing done by an outside appraiser, it has since been an in-house process and has resulted in inconsistent valuations. A project of this size will require formal bids. Commissioners directed assessor to prepare bid specs for the next meeting.

No action taken on appointment for Hospital Board. Commissioners will advertise for position before appointing anyone.

With no further business to come before the board, Chairman Brown adjourned the meeting at 10:25am.
