The regular meeting of the Chase County Commissioners was called to order by Chairman Jacci Brown at 8:00am on Tuesday, August 26, 2025, in the meeting room at the Chase County Courthouse. Also present were Commissioners Billie Muehlenkamp and Kurt Bernhardt, County Attorney Joel Burke, Emergency Manager Duane Dreiling, Deb Hayes for Imperial EMS and County Clerk Wendy Moe. The meeting had been advertised in the Imperial Republican and on the County website. The agenda and open meetings act were posted.

Duane Dreiling was present to discuss road conditions due to recent rains and correspondence received from the City of Imperial concerning the RAVE Emergency Communication Service system. The City has notified the County that, due to the successful launch of the City of Imperial's mobile app earlier this year, they no longer desire to participate in the cost of using Rave following the end of the current agreement.

Deb Hayes spoke to the Board concerning the need for EMS drivers, and how to go about scheduling drivers for transfers as she has had interest from several new people willing to drive for transfers. Board recommended that she use the regular service drivers when available and offer transfers to them before other part-time standby drivers.

County Attorney Joel Burke notified the Board that he has hired a Deputy County Attorney to begin on October 1, 2025. Deputy will handle mostly juvenile matters, school truancy, etc.

Concerning the agenda item of Don Wilson Audit approval, Board noted that they will plan to attend the October meeting of the Fair Board to review Don's audit findings with them as well as other concerns.

Claims were reviewed. Commissioner Brown questioned the claim to Theatrical Media Services for \$49,750. Claim was for payment of the stage rental for fair concerts. Commissioners intend to use this years allocated fair funds for facility improvements at the fairgrounds. Commissioner Bernhardt moved to approve claims as submitted, with the exception of claim #85622 to Theatrical Media Services, payment of which is denied. Motion seconded by Commissioner Brown.
