Chase County Commissioner Meeting July 12, 2022

The regular commissioner meeting was called to order at 8:00 a.m. on Tuesday, July 12, 2022 at the courthouse meeting room. Present were commissioners Jacci Brown, Duane Dinnel, Dennis Kunnemann, county clerk Debra Clark and county attorney Arlan Wine.

Notice of the meeting was advertised in the Imperial Republican on July 6th. An agenda was kept current and available in the office of the county clerk. The agenda and open meeting act are posted. The agenda was posted to the website on July 11th.

Shannon Hamilton and Ryan Stromberger joined the meeting at 8:00 a.m. Shannon informed the board that he would be moving away from the county. He is requesting to have Ryan Stromberger appointed to the zoning board. He indicated that the Vice Chairman would be filling the Chairman position until January at which time there would be re-election of officers. Discussion followed.

Jacci Brown moved to appoint Ryan Stromberger to the zoning board.

Duane Dinnel moved to table the appointment and get information of the open position out to the public.

Additional discussion followed. Shannon Hamilton left the meeting at 8:25 a.m.

Duane Dinnel withdrew his motion.

Dennis Kunnemann seconded Jacci Brown's motion. Jacci-yes; Dennis-yes; Duane-yes; motion carried.

Duane Dinnel moved to approve the minutes of the June 28th meeting. Jacci Brown seconded. Duane-yes; Jacci-yes; Dennis-yes; motion carried.

Toney Krajewski has joined the meeting.

Dennis Kunnemann asked about the Champion bridge project. He asked about the decision to reduce from two culverts to one culvert. Toney indicated he gave his approval for the change.

Jacci Brown indicated that she called the state concerning the reporting requirements for Transit and found that some of those are not mandated. She recommends reverting back to Chase County dispatch, at least for Diane Mathews. Duane Dinnel prefers reverting back all or none.

Jacci Brown moved to revert back to in-house. Duane Dinnel seconded. Jacci-yes; Duane-yes; Dennis-yes; motion carried.

Viaero Fiber Networks has asked to add a handhole to their existing fiber optic to service two customers in Champion. One location is 385 Broadway St. and the other is 300 North St.

Dennis Kunnemann moved to approve the applications by Viaero. Duane Dinnel seconded. Dennis-yes; Duane-yes; Jacci-yes; motion carried.

Region II Human Services has sent notice that the requested match for Chase County for FY 2022/23 is \$16,032.65. Their total budget is \$402,167.04. Jacci Brown moved to approve payment to Region II on a quarterly basis. Duane Dinnel seconded. Jacci-yes; Duane-yes; Dennis-yes; motion carried.

No IT report received. Item is tabled to next agenda.

Hospital minutes for April and May were received and reviewed by the board.

Fair Board meeting minutes for April and May were received and reviewed.

Claim listing was passed out for review. They had also received by e-mail on Monday.

Jack Baker arrived at 9:10 a.m. to update the board on the road projects. During the pre-construction meeting it was discovered that the East end of the Champion project was ending one-half mile earlier than the group thought it would. Discussion on extending the paving work on 734 Road to include an additional ½ mile east.

Werner provided a summary of the work to add up to ¾ of a mile of additional pavement overlay and SMI membrane which would match the section of the rest of the roadway improvements. This would include an additional ½ mile east on 734 Road and an additional ¼ mile north to the State pavement on 327 Ave.

Duane Dinnel moved to execute a change order and add ¾ mile at \$336,778.00. Dennis Kunnemann seconded. Duane-yes; Dennis-yes; Jacci-yes; motion carried. The change order will be sent for signatures later this week. Jack Baker left the meeting at 9:30 a.m.

Jacci Brown moved to approve claims as submitted. Duane Dinnel seconded. Jacci-yes; Duane-yes; Dennis-yes; motion carried.

Duane Dinnel moved to increase the transit drivers fifty cents per hour. Dennis Kunnemann seconded. Duane-yes; Dennis-yes; Jacci-yes; motion carried.

With no further business to come before the board the meeting adjourned at 12:15 p.m. The next regular meeting of the board will be July 26, 2022.
