Commissioner Meeting July 26, 2022

The Chase County Commissioners meeting was called to order at 8:00 a.m. on Tuesday, July 26, 2022 by Chairman Jacci Brown. Also present are commissioners Duane Dinnel and Dennis Kunnemann; county clerk Debra Clark, road superintendent Toney Krajewski and deputy county attorney Rory Roundtree. Kurt Bernhardt is also in attendance.

Notice of the meeting had been advertised in the Imperial Republican. An agenda had been kept current and available in the office of the county clerk. It was uploaded to the county website on July 25th.

Auditor Don Wilson joined the meeting to review the financials with the board.

There was no one from the public for open forum so the meeting began with a discussion concerning the auditor's request to audit the Chase County Ambulance accounts. Deb Hayes and Craig Loeffler were present. They felt they should not have to be audited by the county auditor. The request was made because of some State monies sent to the ambulance that went to the service rather than the County Treasurer for reimbursement of training. They indicated that was for training paid for by the Imperial EMS.

Discussion was held concerning the status of those who volunteer for ambulance runs. They are currently treated as 1099 recipients. Deb Hayes indicated that statute says when the pager goes off, they are covered by county insurance. She also indicated they use the county tax id #. The county does pay for the ambulances and supplies needed. Volunteers are paid for out of county runs for the Imperial crew and all runs for the Wauneta crew. Imperial EMS is paid for the local runs, rather than the individuals making the run.

Commissioner Kunnemann indicated that we are trying to be accountable to our auditor.

Deb Hayes indicated the Imperial EMS is applying for a 501c3. They will have their board vote on the county auditing their books. Their next meeting is the end of August.

Don Wilson indicated he would need all their bank statements and images of checks from January 2021 forward thru June 2022. He would also want their treasurer's reports and minutes of meetings.

Duane and Dennis told them how much they appreciate what the volunteers do. Duane indicated that they only want to help. Deb and Craig left the meeting at 8:35 a.m.

Road Superintendent Toney Krajewski gave an update on the Champion/Wauneta Road project. There will be a change order coming to extend the Wauneta project a short distance. Toney left the meeting.

Don Wilson gave a brief audit review. He discussed the inheritance tax fund, ARPA funds, Hospital Sinking and the road project bond. Because of the balance on hand in the hospital sinking, he suggested eliminating the hospital levy.

Some additional discussion concerning the financials was held.

Duane Dinnel moved to approve the minutes of the July 12th meeting. Dennis Kunnemann seconded. Duane-yes; Dennis-yes; Jacci-yes; motion carried.

Jacci Brown had to leave the meeting for jury duty at 8:45 a.m. Vice Chairman Duane Dinnel took over as chairman for the remainder of the meeting.

Auditor Wilson advised the board that he felt the buyout purchase of the tractors would be considered a special purchase and should have been advertised. Commissioner Dinnel questioned that because of the lease purchase option. He indicated that their value was greater than the purchase price. The auditor did indicate he would have to write them up in his audit findings report.

Ambulance billing was discussed. Don Wilson did indicate Dundy County does contract it out. The board asked that ambulance billing and write-offs be added to the next agenda. The clerk will check with West Central clerks on who does their ambulance billing.

The county board meeting recessed for a Board of Equalization meeting at 9:20 a.m. The county board meeting resumed at 9:30 a.m.

Tori Otzel and Terri State gave a brief report on the onsite IT security survey that had been done by Applied Connective. A quote to change the courthouse to one domain and monthly management of services was provided. This will be carried forward to the next agenda. Terri left the meeting at 9:40 a.m.

Assessor Dotty Bartels joined the meeting. The proposed contracts for commercial reappraisal were reviewed. Copies had been provided to the board prior to the meeting. Stanard Appraisal Services Inc. quoted \$138,700 for the review of the 419 parcels. Lake Mac Assessment, LLC quote was \$83,800.

Dennis Kunnemann moved to hire Lake Mac Assessment, LLC to do the commercial reappraisal. Duane Dinnel seconded. Dennis-yes; Duane-yes; Jacci-absent; motion carried.

Duane Dinnel moved to offer the road secretary position to Amy Rozelle to commence November 1st. Dennis Kunnemann seconded. Duane-yes; Dennis-yes; Jacci-absent; motion carried.

Dennis Kunnemann moved to pass Resolution 2022-16 for transfer of E911 Funds from Fund 2910 to Funds 2913 and 2914 as per the auditor. Duane Dinnel seconded. Dennis-yes; Duane-yes; Jacci-absent; motion carried. These had just been receipted into the wrong funds when received. A complete copy of the resolution is available in the office of the county clerk.
