Chase County Commissioners May 27, 2025

The regular meeting of the Chase County Commissioners was called to order by Vice-Chairman Kurt Bernhardt at 8:00am on Tuesday, May 27, 2025, in the meeting room of the Courthouse. Also present were Commissioner Billie Muehlenkamp, County Clerk Wendy Moe, Assistant Highway Superintendent Dick DeWester and Road Secretary Jordan Beard. Commissioner Brown was absent. The meeting had been advertised in the Imperial Republican. The agenda and open meetings act were posted.

Dick DeWester was present for Open Forum to update commissioners on general happenings in the Road Department.

Pam Bunker and Karon Pantera joined the meeting on behalf of the Wauneta Senior Center to request KENO funds to purchase a new sanitizer for the center. After dishes are washed and rinsed, they must be run through the sanitizer. The one currently in use is old and outdated and difficult to find parts for. They presented prices and specs on two different options and noted that they are still waiting to hear from the plumber about the price for installation. Commissioner Bernhardt moved to approve expending KENO funds to purchase the CMA Dishmachines Model No. E-3D-EXT sanitizer in the amount of \$4775.00 and to pay for the plumbing and installation fees. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Wauneta EMS needs a new printer/scanner/copy/fax machine, Ambulance Administrator Jordan Beard presented a quote for a Lexmark XC2326 from Office Services for \$1198.00. Commissioner Muehlenkamp moved to approve the purchase of the Lexmark XC2326 for Wauneta EMS. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Transit Administrator Jordan Beard noted that one of the Transit Vans needs repairs done, Deveny has quoted \$2900. The van has over 200,000 miles on it and Jordan thinks purchasing a new van would be a good option. Board instructed Jordan to proceed with repairs for the van and start the process of purchasing a new one.

Representatives from Titan and 21st Century were present for agenda item of Mower Tractors. Commissioner Bernhardt noted that the County will have to advertise for bids before tractors can be purchased. Commissioner Bernhardt moved that the County advertise for mower tractor bids to be opened on June 10th at 8:30am. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried. A complete bid spec sheet will be available in the office of the Road Secretary.

Correspondence from Bridge of Hope was reviewed. Board directed Clerk to allocate \$500 for Bridge of Hope when preparing the 25-26 Budget.

Commissioner Bernhardt moved to approve claims as submitted. Motion seconded by Commissioner Muehlenkamp. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Commissioner Muehlenkamp moved to approve the minutes of the May 13, 2025, meeting as written. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – absent; Bernhardt – yes. Motion carried.

Agenda item of Champion Mill Groundskeeper/Maintenance Contract will be addressed at the next meeting.

Assessor Tori Mueller joined the meeting to present quotes from vendors for GIS services. Due to the cost of our current vendor, approximately \$25,000 annually, plus the fact that in March of 2026 they will no longer provide ARCmap services and have not yet identified a solution, Tori believes the County should consider other vendors. She presented the following options: Schneider Beacon, offering both website hosting and parcel maintenance for \$21,468 plus a one-time set up fee of \$10,000. For only parcel maintenance services the cost would be \$11,916 annually and a one-time set up fee of \$2,100; Sidwell for parcel maintenance services only, \$12,725 for year one, \$7,361 for year two and \$7,572 for year three. Tori is still waiting for a quote from Vanguard, website only, not parcel support. Based on numbers quoted last year, she anticipates an initial fee of \$13,000 and an annual fee of \$1,000 thereafter.

At 9:00 Vice-Chairman Bernhardt recessed the meeting for Board of Equalization.

Meeting reconvened at 9:25 with Commissioners Bernhardt and Muehlenkamp, Assessor Tori Mueller and County Clerk Wendy Moe present.

The County's GWorks contracts are set to renew on July 1, Assessor is waiting for clarification on current contract requirement for termination, it is unknown if 30 or 60 days are required. After further discussion Commissioner Bernhardt felt that at this time there is not enough information available to make an informed decision, no action taken.

With nobody present for open forum and no further business to come before the Board, Vice-Chairman Bernhardt adjourned the meeting at 9:32am.
