Commissioner Bernhardt moved to table the Prairie Dog Nuisance Control resolution agenda item. Motion seconded by Commissioner Brown. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. Item tabled.

Commissioner Brown moved to approve Resolution 2025-23 Year-End Certification of County Highway Superintendent. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. A complete copy of the resolution is on file in the office of the County Clerk.

Commissioner Bernhardt moved to approve Resolution 2025-24 for Authorization for Transfer of Funds per County Budget Document, transferring funds from Inheritance Tax Fund into Fair Fund and E911 Fund. Motion seconded by Commissioner Brown.

Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. A complete copy of the resolution is on file in the office of the County Clerk.

Commissioner Brown moved to approve Resolution 2025-25 to transfer budgeted funds from the Road fund to the Champion Wauneta Road Project Bond Fund, as per the budgeted transfers in the County Budget Document. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried. A complete copy of the resolution is on file in the office of the County Clerk.

Commissioner Brown moved to sign the Memorandum of Understanding between the Nebraska Department of Veterans' Affairs and Chase County for the period of January 1, 2026, through December 31, 2028. Motion seconded by Commissioner Bernhardt.

Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Assessor Tori Mueller joined the meeting for the agenda item of E-Filing of Personal Property via Vanguard. She explained that providing this service would cut down on postage expenses and data entry time in the Assessor's office. Individuals or their designee (CPA, etc.) will be able to log in to the website using a provided PIN to file their personal property information. The initial website license fee will be \$1000 and then \$250 annually, along with an initial fee of \$2500 for the CAMA PP Website with eFile online submissions License Fee and then \$1750 annually. Assessor Mueller indicated that she has the available funds in her budget to cover this expense. Commissioner Muehlenkamp moved to approve the e-filing of personal property via Vanguard, per the request of Assessor Mueller. Motion seconded by Commissioner Bernhardt. Muehlenkamp – yes; Brown – yes; Bernhardt – yes. Motion carried.

Emergency Manager Duane Dreiling joined the meeting to discuss the RAVE system. As the City of Imperial has opted to withdraw from the current agreement at the end of the year, the County needs to remove the citizens who reside within the city limits from the RAVE alerts. This process will be completed by December 31.

At 8:45 Chairman Brown recessed the meeting for Board of Equalization. Meeting was reconvened at 8:50 with three Commissioners and County Clerk in attendance.

With nobody present for Open Forum and no further business to come before the Board, Chairman Brown adjourned the meeting at 8:50am.
